Indemnity Agreement

I hereby fully indemnify, save and hold harmless The City of Gulf Breeze their respective officers, directors, employees, agents successors and assigns (“indemnities) against any and all liability, damage, loss, claims, demands, and actions of any nature whatsoever, on account of personal injuries (including, without limitation on the foregoing worker’s compensation and death claims), or property loss or damage of any kind whatsoever, which arise out of or are in any manner connected with, or caused by, or are claimed to arise out of or be in any manner connected with, or caused by, either proximately or remotely, wholly or in part, an act or omission, negligence or misconduct, or as a result of a breach of this Agreement by Indemnitors or any of the Indemnitor’s agents, servants, employees, contractors, patrons, guests, licensees, or invitees entering upon the implied invitation or permission of the indemnitors or when any said injury or damage is the result, proximate or licensees, or invitees of any law, ordinance, or governmental order of any kind.

Sales Tax Indemnity Agreement

I hereby fully indemnify, save, and hold harmless The City of Gulf Breeze, their respective officers, directors, employees, agents, successors, and assigns (“indemnitees”) against any liability, damage, loss, claims, demands, and actions of any nature whatsoever on account of sales tax attributable to vendor’s merchandise. The vendor is responsible for calculating and reporting all applicable sales tax on the vendor’s merchandise.

Exhibitor Agreement

- Vendor balance (\$20) must be paid **BEFORE** the event. No vendor payments will be collected during the event. We do **NOT** accept, PayPal, Venmo, or other apps as payment. **ONLY** cash, check, or credit card payments are accepted.
- Vendors **MUST** have a seasonal activity (mini carnival-style games/giveaways) for kids. This will be located in your second parking lot spot. You are welcome to use your car for mini carnival-style games
- Vendors must pass out Halloween candy to all children (ALL AGES) at their booth, bring plenty of candy.
- Vendors are **HIGHLY** encouraged to dress up in their spookiest Halloween costumes.
- No two booths will sell the same items.
- There is a \$15 service charge on all returned checks
- Vendors must stay at their booth from start to finish 6:00 pm-8:00 pm. **NO** cars will be allowed to drive around the event area starting from 5:30 pm – 8:30 pm (safety issue).
- Requests for specific space locations will **NOT** be considered (unless you are a food truck). Each vendor has two side-by-side, park lots spots.
- The Market Coordinator reserves the right to change any assigned exhibitor space and relocate for any reasonable cause in her sole judgment
- All merchandise is subject to the Coordinator’s approval. The Coordinator reserves the right to cancel a booth reservation or require alteration of any merchandise or activity that is inconsistent with the quality, theme, or image of the market
- Vendors must adhere to scheduled setup and teardown times
- Vendors must keep the booth open during all market hours and watch over the space at all times. There will be no early packing during the event unless by permission
- Vendors **MUST** decorate their exhibit with Halloween-themed entertainment.
- The market is not responsible or liable for the loss of or damage to the vendor’s property from theft, disappearances, or damages by fire, water, accident, or any other cause
- Vendor is responsible for the payment of any damage charges assessed by the City of Gulf Breeze Parks and Recreation Department for accidental damage caused by the vendor or for failure to observe the rules and regulations for the construction and operations of his/her booth
