



## **Gulf Breeze Parks & Recreation Co-Ed Basketball League**

**18+**

### **General**

- 3-on-3 basketball league
- No players may play on more than one team
- GAME TIME IS FORFEIT TIME
- Must checkup ball & pass off to begin
- No jewelry or headwear is permitted
- Refs will be provided

**Season Date: April 1<sup>st</sup> – May 29<sup>th</sup>**

**1-2 games a week on Tuesdays & Thursdays 6 p.m. to 9 p.m. (will include a  
playoff)**

**Regular Season: 8 games + 2 week playoffs**

## **Game Info**

- 1.) Half-court game played by two teams consisting of 3 players each
- 2.) Games will run until the final score is 21 or 20 minutes have passed.  
  
Teams matched against each other will play against their opponent for the best of three matchups. The winner of two of the three games will report the result to the supervisor on duty for the record
- 3.) A team must be present 10-15 minutes before its start time with a team of 3 present, or a forfeit will be deemed for that team

### **Roster:**

- 4.) Team rosters can consist of a maximum of 6 players or a minimum of 4
- 5.) All players must be listed on rosters
- 6.) Rosters are frozen after signups (no exceptions) no one else can be added at a later date
- 7.) Random roster checks will be issued and players must provide a valid Drivers License or photo I.D. for validity
- 8.) If a roster is to be found in violation of this, that team will be forfeited for the season

## **Points:**

### **9.) Points will be awarded as follows:**

- 1 point for a made field goal inside the 3-point arc
- 2 points for a made field goal outside the 3-point arc
- Only need to win by 1 point
- If a foul is issued there will only be one free throw for the player who received the foul
- A player can foul out with 5 fouls

### **Timeouts/Substitutions:**

- 10.) There are NO team timeouts. The only time a timeout will be in play is for an injury
- 11.) Substitutions can be made following a basket or stoppage of play

### **Official Game:**

- 12.) If the 20-minute time limit is up and neither team has reached 21, whichever team is up will take that game
- 13.) If both teams are tied at the 20-minute time limit, a 1-minute Overtime will be accessed. If both teams are still tied after the Overtime has been played then the next team to score wins the matchup.

14.) If a team misses the basket and the opposing team rebounds the ball, they must bring the ball back out past the 3-point line.

15.) If the ball is stolen, blocked, or does not hit the rim you can go straight up with it

**Uniforms:**

16.) Teams should arrive and play wearing the same colors as their teammates. If a team shows up to play a game and not all players have the same color then pennies may be issued to that team

**Captain/Team:**

17.) The team captains at the end of the game will report the results of the games to the supervisor on duty

18.) All players must either have a scorecard or a captain provide a roster sheet for who is there playing

**Court/Stands:**

19.) Only Officials, players (5), and one (1) coach per team are permitted to be on the main floor. Any guests attending the event will be directed to watch from the bleachers

**Drug/Alcohol Policy:**

20.) Tobacco and Alcohol are PROHIBITED. Failure to comply with the rules and regulations will result in your team forfeiting the game and expulsion from the league

**Enforcement:**

21.) Dunking during the game is permitted but not allowed during a stoppage of play or dead ball

**Game ball:**

22.) The rec will provide a game ball for league usage. No outside ball will be used for any game and the ball in play will be a Men's Evolution size 29 ball

**Communications:**

23.) The captain will speak for the team and communicate with the referee or supervisor handling their game. The captain and team will speak respectfully when handling conversations

**Jump ball:**

24.) The home team will shoot for the ball at the beginning of the game to determine the jump ball

**Cancellations:**

- 25.) Due to circumstances that may prevent a game from happening and a cancelation occurs. There would not be a negative effect on a team's record and a makeup game may potentially be scheduled

**Injury/Blood:**

- 26.) If a player receives an injury during the game and blood is shown. That player must immediately leave the game and can not return until the bleeding has stopped

**Unsportsmanlike Conduct:**

- 27.) There will be no exceptions for unsportsmanlike conduct during a game. If it is seen/proven that someone is acting unsportsmanlike, they may be asked to leave the facility. The player will be allowed back for the following game on a new day but if that player receives another unsportsmanlike call, the player will not be allowed back to any following games for the team. Consequences can include a permanent facility ban

**What to bring to Check-in:**

- 28.) Team rosters (Must have completed rosters to participate)

- 29.) Signed waiver sheets (Players must sign waivers to participate)
- 30.) Each team must present their completed rosters and have paid their entry fee in full before playing their first game

**Warm-Ups:**

- 31.) 3-5 minutes before the game starts
- 32.) Once the first game has concluded, there will be an additional 3–5 minute break for water and bathroom

**Playoffs and Standings:**

- 33.) Scheduling will be conducted once regular season games are finished.

Seeding will go as follows:

- #1 v. #10, #2 v. #9, so on so forth

**Seeding/Tie Breaker:**

**3.) Opponent points forward**
